ARTICLE II Section 1 d.

Updated the definitions for Life Membership Classes

OLD

Life Member

I This class shall be opened to persons who hold a valid FCC Amateur Radio License and have been a Full Member in good standing for at least five (5) years.

ii Life membership may be bestowed on a Full Member by the LARA Board of Directors, for individual(s) that have provided services that are above and beyond what is expected of a full member.

iii Life Memberships may be purchased for the then current fee established by the board of directors.

NEW

Life Member

I This class shall be opened to persons who hold a valid FCC Amateur Radio License and qualify for a Full Membership.

ii The LARA Board of Directors may bestow a life membership to a Full Member in good standing for at least (10) years, who have provided services that are above and beyond what is expected of a full member. These Life members will be known as an honorary life membership.

iii Life Memberships may be purchased by those individuals who qualify for Full Membership for the then current fee established by the board of directors. These will be known as benefactor life members.
